#### FSA CENTRAL DISTRICT GENERAL MEMBERSHIP MEETING

### Saturday, March 7, 2020

The Central District Board of the FSA met Saturday, March 7, 2020 at Sanlan RV and Golf Resort. President John Houghtaling called the meeting to order at 9:30 am. John offered an invocation followed by Cheryl Conkle leading us in the pledge to the flag. John expressed his thanks to Linda Armstrong and Sanlan RV and Golf Resort for hosting our meetings at this central location.

Roll call was taken and all members were present with the exception of State Delegate Larry Brown, HOF Curators Bob and Linda Marshman and Webmaster/KOR Glenn Monroe. Introduction of club presidents and guests followed.

George Adyns made a motion to suspend the reading of the January 11, 2020 minutes as they have been posted on the website. Jim Corbeil seconded the motion.

#### **REPORT OF OFFICERS**

**President John Houghtaling-** John commented that the interest in amateur shuffling seems to be on the rise. He so appreciates all the work of the CTL District Board. He is pleased with all of this year's accomplishments and thanks to all for their help and support.

**1**<sup>st</sup> **VP Jim Chandler-** Jim is going off the Board this year. He has enjoyed the years spent and expressed his thanks to all, especially to Ginny for her help in scheduling each year's tournaments.

**2nd VP Jim Corbeil -** Jim says all is ready for the Reiny Masters this years. There is no need for any playoffs. The pins are ready. He just needs to contact those individuals with last year's trophies.

**3<sup>rd</sup> VP Linda Armstrong**- In approximately 1 ½ weeks, Linda will be sending out notices to all member clubs to coordinate ads for next year's PREVIEW. For those clubs sending checks, please date your checks to the FSA as of June 1<sup>st</sup> since there were some issues last year. Linda will send out a bulk mailing. She would like all clubs to let her know when the FSA cashes each club's check.

**4<sup>th</sup> VP Tim Baker-** Tim commented on how successful this year has been. He said they had 5 new amateurs playing in their first or second tournament. Tim also appreciates the Pros who take their time to work with and encourage amateur play. For instance, David Earle who directed a modified single mingle at Forest Lake Estates, plays an important role in this endeavor. David said that a modified single tournament is the easiest format in which to get amateurs started. A director needs to make them feel comfortable and create an atmosphere where the rules are taught gently.

Tim is stepping down this year as he has reached Pro status but has enjoyed his duties and enjoyed his time working with the Board. John Houghtaling congratulated Tim on his Pro status.

**Secretary Cheryl Conkle** - Cheryl is also stepping down this year as secretary. She expressed her heartfelt thanks to the Board for their support over the years. She commented that she has fond memories of working with four different presidents over the years.

**State Delegate Larry Brown**- John Houghtaling shared that Larry is doing well and will be back down for a few days during the Avon Park tournament. Larry is largely responsible for the success of the CTL District. Everyone loves Larry and wants to see him back down here again.

Alternate State Delegate Judy Holloway- Judy said we need to encourage Larry to stay this coming fall and get involved back into shuffling. She also said that amateurs need to reprint their 2020-21 schedule. There are errors in the following tournaments: A04, A05, A09, A10. The State meeting is Saturday March 14 at Sebring.

**Tournament Director George Adyns**- George reported that the first page of the CTL District Pro schedule is correct but the error is on the Printable copy. CDP 19 should read March 5-6, not 4-5. This year we had 26 more shufflers in State tournaments and 18 less in District tournaments. We were 7 couples short in mixed tournaments. We were down 34 amateurs at the Winter Haven tournament mostly due to inclement weather.

Webmaster/KOR Glenn Monroe—George Adyns reported in Glenn's absence. There are 13 State Ams moving up to Pro and 8 are on the bubble. There are 21 District Ams moving to State Am status with 20 on the bubble. George also took this time to compliment Tim Baker. He said Tim exemplifies everything we want in an Amateur Representative. Tim was everywhere, shuffling and representing amateurs. A perfect Amateur Rep! Thank you, Tim.
